Its images are your three dimensional compass during endovascular procedures. They allow surgeons and interventionalists to plan, perform, and follow-up procedures with confidence.

VesselNavigator, Philips next generation image fusion technology, allows reuse of 3D vascular anatomical information from existing CTA and MRA datasets as a 3D roadmap overlay on a live X-ray image. With its excellent visualization, VesselNavigator provides an intuitive and continuous 3D roadmap to guide you through vasculature during the entire procedure. This reduces the need for a contrast enhanced run to create a conventional roadmap.

### 3D image fusion in advanced endovascular procedures

Studies<sup>1,2</sup> have shown that a 3D perspective of anatomy is desirable for catheter guidance and device placement because of its advantages over 2D imaging. Previously acquired diagnostic CTA and MRA datasets show the 3D anatomical structure of vasculature, in a way that's similar to an open surgery view.

Now with VesselNavigator clinicians can easily segment the 3D vessel structures from these datasets and fuse them with the 2D fluoroscopy image to get the 3D perspective of anatomy in the X-ray image.

### VesselNavigator real-time navigation

VesselNavigator can be used for any type of endovascular procedure. It is especially beneficial for complex and tortuous vasculature where it is challenging to accurately navigate and place stents or for procedures where contrast use should be minimized.

VesselNavigator's 3D image fusion offers numerous advantages compared to 2D imaging and 3D roadmap alone:

### Real-time navigation supports confident decisions during procedures

Unlike 2D angiography images which can be limited by vessel superpositioning or foreshortening,<sup>1</sup> VesselNavigator provides three dimensional views of vasculature that allow you to easily define the right projection angle<sup>2</sup> for optimal navigation and stent placement. With the use of ring markers you can easily indicate the ostia and landing zones.

# **Lower barriers** for minimally invasive interventions

We have a long standing commitment to reducing dose and contrast medium through a set of techniques, programs, and practices that focus on delivering equivalent image quality at a fraction of the dose.

#### Contrast medium usage and procedure efficiency

VesselNavigator's roadmap covers the entire MR or CT volume, so you can navigate through the entire vessel without needing to make contrast runs at each step of the procedure. Reusing a pre-acquired CTA or MRA as overlay reduces the need for a contrast enhanced overlay.

A study of 23 patients<sup>1</sup> has shown to reduce average contrast medium usage from 235 to 65 ml (72%) during endovascular repair of complex aortic aneurysms with the use of Philips CTA image fusion guidance. No intraprocedural contrast agent injection was required to create a roadmap. Contrast agents were mainly used before and after visceral stent placement and for the final control angiography.

Besides reducing contrast, VesselNavigator can potentially reduce procedure time significantly. A study of 62 patients<sup>2</sup> showed an average reduction in procedure time from 6.3 to 5.2 hours during FEVAR/BEVAR procedures with the use of Philips CTA image fusion guidance. This was possible due to more efficient target vessel catheterization under fusion roadmap guidance.

## Intuitive use stay focused on your patient

Through its advanced imaging capabilities, VesselNavigator is the tool that creates a seamless clinical workflow. It guides you through four simple steps:

- 1: Select the vessels for overlay with a one-click vessel segmentation
- 2: Add ring markers for ostia and landing zone indication and define planning angles
- 3a: Fuse the CT or MR dataset with the 2D images by mapping on bone structures or
- 3b: Fuse the CT or MR dataset with the 3D images by selecting three points in each dataset
- 4: The fused image can now be used as Live Image Guidance during the procedure

During the procedure VesselNavigator provides a real-time overlay in any projection and any table and system position. You can also choose from a variety of superior volume rendering visualization options, customizable per physician preference.
